AND 56 OF THE REPRESENTATION OF THE PEOPLE ACT, 1951 –  
APPOINTMENT OF THE DATES AND FIXATION OF HOURS OF POLL  
FOR THE BYE-ELECTION TO THE ANDHRA PRADESH LEGISLATIVE  
ASSEMBLY FROM 248-PULIVENDLA ASSEMBLY CONSTITUENCY.

The following notification No. 100/AP-LA/2/2009 of the Election  
Commission of India, New Delhi, dated the 25<sup>th</sup> November, 2009 / 4  
Agrahayana, 1931 (Saka) is published:-

**NOTIFICATION**

No.100/AP-LA/2/2009: - **Whereas**, the seat of Dr. Y.S. Rajasekhara  
Reddy in the Legislative Assembly of the Andhra Pradesh State, elected from  
248-Pulivendla Assembly Constituency, has become vacant on 02.09.2009, by  
reason of his death; and

2 **Whereas**, a bye-election is to be held for the purpose of filling the  
vacancy so caused;

3 **Now, therefore,** in pursuance of sub-section (1) of Section 150, and Sections 30 and 56 of the Representation of the People Act, 1951 (43 of 1951), the Election Commission of India hereby:-

(A) **Calls upon** the said 248-Pulivendla Assembly Constituency in the State of Andhra Pradesh to elect, before the 31<sup>st</sup> December, 2009 (Thursday) and in accordance with the provisions of the said Act and of the rules and orders made thereunder, a person, for the purpose of filling the said vacancy in the Legislative Assembly of the State; and

(B) **Appoints,** with respect to the said election,-

- (a) the 02.12.2009 (Wednesday), as the last date for making nominations;
- (b) the 03.12.2009 (Thursday), as the date for the scrutiny of nominations;
- (c) the 05.12.2009 (Saturday), as the last date for the withdrawal of candidatures;
- (d) the 19.12.2009 (Saturday), as the date, on which a poll shall, if necessary, be taken;
- (e) the 31.12.2009 (Thursday), as the date before which the election shall be completed, and

(C) **Fixes the hours** from 8.00 A.M. to 5.00 P.M., as the hours during which the poll shall, if necessary, be taken on the date specified above for the election.
