**ELECTION COMMISSION'S NOTIFICATION UNDER SECTION 150, 30 AND 56 OF THE
REPRESENTATION OF THE PEOPLE ACT, 1951 - APPOINTMENT OF THE DATES AND
FIXATION OF HOURS OF POLL FOR THE BYE ELECTION TO THE ANDHRA PRADESH
LEGISLATIVE ASSEMBLY FROM 99-GHANPUR (STATION) (SC) ASSEMBLY
CONSTITUENCY.**

The following notification No.100/AP-LA/4/2012 of the Election Commission of India, New Delhi, dated the 22nd February, 2012 / 3 Phalgun, 1933 (Saka) is published:-

NOTIFICATION

No. 100/AP-LA/4/2012: - Whereas, the seat of Sri Rajaiah Thatikonda in the Legislative Assembly of the Andhra Pradesh State, elected from 99-Ghanpur (Station) (SC) Assembly Constituency, has become vacant on 28.11.2011, by reason of his resignation; and

2. **Whereas**, a bye-election is to be held for the purpose of filling the vacancy so caused;

3. **Now, therefore**, in pursuance of sub-section (2) of Section 150, and Sections 30 and 56 of the Representation of the People Act, 1951 (43 of 1951), the Election Commission of India hereby:-

(A) **Calls upon** the said 99-Ghanpur (Station) (SC) Assembly Constituency in the State of Andhra Pradesh to elect, before the 25th March, 2012 (Sunday) and in accordance with the provisions of the said Act and of the rules and orders made thereunder, a person of the Schedule Caste of the State for the purpose of filling the said vacancy in the Legislative Assembly of the State; and

(B) Appoints, with respect to the said election -

- (a) the 29.02.2012 (Wednesday), as the last date for making nominations;
- (b) the 01.03.2012 (Thursday), as the date for the scrutiny of nominations;
- (c) the 03.03.2012 (Saturday), as the last date for the withdrawal of candidatures;
- (d) the 18.03.2012 (Sunday), as the date, on which a poll shall, if necessary, be taken;
- (e) the 25.03.2012 (Sunday), as the date before which the election shall be completed, and

(C) Fixes the hours from 8.00 A.M. to 5.00 P.M., as the hours during which the poll shall, if necessary, be taken on the date specified above for the election.
