Two criminal and two civil cases were filed by my step mother Dr.(Mrs).Bharathi in respect of two house properties left behind by my (late) father, after his death in the year 1998 against me and other family members as she was not satisfied with the share allotted to her by my father in the registered will left by my father.

(i) Section of the Act and description of the offence for which cognizance taken:
Case:-(1) Secs 465 and 471 R/w 120 B of IPC The allegation is that the sign of Dr.Barathi, my step mother was forged in the application for mutation in municipal records..

Case:-(2) Secs 199, 406,420,468,471 R/w 34 IPC The allegation is that her sign was obtained on a blank affidavit paper and used for transfer of a plot from coop-society on my daughter's name and my daughters age was wrongly declared.

(1) The X Adl Chief M.M. Secunderabad has taken Cognizance.

- 1) Cr.R.P.No.426/01 was filed before the M.S.J, Hyderabad against the orders of Cognizance. Case was remanded back to Lower court with certain observations.
- 2) Cr.R.P.No.76/04 on the file of VI Adl M.S.J. Secunderabad was filed against the orders of XVIII M.M.in C.C.No.6/01 Dt.16-2-04.
- 3) Cr.Ptn. No.4953/04 for Quash the proceedings was filed before the Honorable H.C.of A.P the case is remanded back to the lower court with certain modifications of the charges. The Case is pending trial before the Lower Court.

2nd Case:

Cr.P. petition on 4462/05 was filed before the Honourable H.C.of A.P for Quashing the order of lower court taking cognizance .The petition was withdrawn.

The Government on a representation has issued orders withdrawing prosecution against me and other family members vide G.O.No.1436 Home (Leg-II) Dept Dt.18-9-06. This order was challenged by my step mother and obtained stay orders of High Court of A.P.

The case is pending trial before the II Adl C. M.M. Nampally , Hyderabad on transfer from X Adl C.M.M. Secunderabad.
