The attention of all the District Election Officers is invited to the references cited. Certain complaints have been received stating that some EROs / AEROs / Designated Officers are insisting on submission of residential proof of the applicants for inclusion in the rolls. It is clarified that there is no requirement for submission of proof of residence along with the applications. Only proof of educational qualification in respect of graduate constituency and certificate issued by the Head of the Institution in respect of Teacher Constituency has to be insisted upon. The Designated Officers / AEROs / EROs shall undertake the supervisory checks with regard to residential status of applicant during the period of disposal of claims and objections as pointed out in para 7 of the Election Commission guidelines.

2. The following clarification may also be kept in view while dealing with applications from Graduates for including in Electoral Rolls.

A person who has been for at least 3 years before the qualifying date (1.11.2006) a graduate of any University in the territory of India or has been in possession of equivalent qualifications listed in G.O.Ms.No.536, G.A.(Elecs.F) Dept., dt.18.09.2006 (circulated to all Electoral Registration Officers, Asst.Electoral Registration Officers and posted on the web site <http://www.ceoandhra.nic.in>.) and is ordinarily resident within the Constituency is entitled to be registered in a graduates' constituency.

3. As regards eligibility of a person for enrolment in Teachers Constituency, it is clarified as follows:

A person shall be entitled to be registered as elector in a Teachers' Constituency, if  
(a) he has been engaged in teaching for a total period of three years, within the six

years immediately before the qualifying date (1.11.2006), (b) he has been so engaged in teaching for the said three year period in any of educational institutions not lower in standard than that of secondary school, (c) is ordinarily resident within the territorial extent of the Teachers' Constituency in which he seeks enrolment.

4. State Government have notified the list of educational institutions not lower in standard than that of a secondary school in G.O.Ms.No.537, G.A.(Elevs.F) Dept., dt. 28.09.2006 (circulated to all Electoral Registration Officers, Asst. Electoral Registration Officers and posted on the web site <http://www.ceoandhra.nic.in>.)

5. All the District Election Officers are requested to intimate the above clarifications to all the Electoral Registration Officers/Assistant Electoral Registration Officers/ Designated Officers and ensure that the guidelines of the Commission are followed scrupulously.
