Sub: Andhra Pradesh Legislative Council – Elections to A.P. Legislative Council – Electoral Rolls of Assembly Constituencies to be taken into criteria for issue of certified extracts to the contesting candidates of Legislative Council - Clarification – Reg.

During the Collectors' & Joint Collectors' Conference held on 14.02.2007 in connection with elections to A.P. Legislative Council certain district Collectors have sought for a clarification as to which Electoral Roll of Assembly Constituencies should be the basis for issue of a certified extract to the contesting candidates of Legislative Council since the Special Summary Revision of Electoral Rolls is in progress in the state. The Election Commission of India vide their letter cited have clarified that the Assembly roll for the purpose of filing nominations during the ongoing Council Elections will be the existing Electoral Rolls of 2006 containing all supplements. The Election Commission of India has further directed that the final publication of the Electoral Rolls of those Assembly Constituencies, which was previously notified as 23.02.2007 be deferred immediately. The new date of final publication of these rolls will be intimated shortly.

2. With reference to Form 2D and Form 2E the Election Commission of India has clarified that all columns of Form 2D and Form 2E are required to be duly filled up during the filing of nominations for Council Elections by the candidates as these are Statutory Forms.

3. All the Collectors & District Election Officers (except Hyderabad) and the Commissioner, Municipal Corporation of Hyderabad & District Election Officer, Hyderabad and all the Returning Officers of Council Constituencies are requested to follow the above instructions of the Commission scrupulously, while accepting/scrutiny of nominations for elections to Council Constituencies.

4. The date of final publication of the Electoral Rolls of those Assembly Constituencies, which was originally notified as 23.02.2007, will be intimated shortly.
