1	Whether the applications in bulk can be accepted from the Head of the institutions of public/private under takings or not;	As per the guidelines of the Commission, the ERO should address all offices, educational and other institutions, banks, firms etc., located in the constituency inviting their attention to the public notice issued by them as well as the advertisement in the newspapers impressing upon them that all qualified persons should apply for inclusion of their names. ERO should also address the Heads of the Institutions, offices, etc., requesting them to collect applications in the prescribed Forms from the eligible persons among their staff for inclusion of their names and to be forwarded to the ERO. Hence, the applications in bulk can be accepted from the Head of the institutions of public/private under takings.
2	Whether the attestation made by the Head of the institution on Photostat copy of the qualifying examination is sufficient in respect of the applications received in bulk from the institutions;	No. It should be verified with the original in the manner stipulated in guidelines.


