THE DISTRICT ELECTION OFFICERS ARE INFORMED THAT THE DRAFT ELECTORAL ROLLS OF MAHABUBNAGAR-RANGA REDDY-HYDERABAD TEACHER'S CONSTITUENCY ARE TO BE PUBLISHED IN THE MANNER PRESCRIBED BY THE ELECTION COMMISSION OF INDIA ON 22.11.2010. THE ADDITIONAL COMMISSIONER (ELECTIONS), GREATER HYDERABAD MUNICIPAL CORPORATION, HYDERABAD IS THE ELECTORAL REGISTRATION OFFICER FOR THIS CONSTITUENCY AND THERE ARE CERTAIN ASSISTANT ELECTORAL REGISTRATION OFFICERS (ie., REVENUE DIVISIONAL OFFICERS) FROM EACH DISTRICT. THE AEROS SHALL BE IN REGULAR CONTACT WITH THE ERO SINCE THE CONSTITUENCY COMPRISES THREE DISTRICTS AND THE ERO PERTAINS TO HYDERABAD. IT HAS COME TO THE NOTICE OF THIS OFFICE THAT THE AEROS OF RANGA REDDY AND MAHABUBNAGAR DISTRICTS ARE NOT COOPERATING WITH THE ERO FOR PROPER DISCHARGE OF HER DUTIES IN PUBLICATION OF ELECTORAL ROLLS ON 22.11.2010. THE DISTRICT ELECTION OFFICERS OF RANGA REDDY AND MAHABUBNAGAR DISTRICTS ARE REQUESTED TO DIRECT THE AEROS OF THEIR DISTRICT TO CONTACT THE ERO IMMEDIATELY AND ENSURE THAT THE DRAFT ELECTORAL ROLLS ARE PROPERLY PUBLISHED ON 22.11.2010.
