No. 322/AP -LC/3/2011 (1) : - WHEREAS, the Governor of the State of Andhra Pradesh has, by notification issued under section 16 of the Representation of the People Act, 1951 (43 of 1951) and published in the official Gazette of the State on 28<sup>th</sup> February, 2011, been pleased to call upon the members of the Legislative Assembly of the State, to elect ten members to the Legislative Council of the State :-

Now, therefore, in pursuance of sub-section (1) of section 39 and section 56 of the said Act, the Election Commission of India hereby –

(A) appoints, with respect to the said election –

- (a) the 7<sup>th</sup> March, 2011 (Monday), as the last date for making nominations;
- (b) the 8<sup>th</sup> March, 2011 (Tuesday), as the date for the scrutiny of the nominations;
- (c) the 10<sup>th</sup> March, 2011 (Thursday), as the last date for the withdrawal of candidatures;
- (d) the 17<sup>th</sup> March, 2011 (Thursday), as the date on which a poll shall, if necessary, be taken;  
and
- (e) the 21<sup>st</sup> March, 2011 (Monday), as the date before which the election shall be completed;

(B) fixes the hours from 9:00 A.M. to 4:00 P.M., as the hours during which the poll shall, if necessary, be taken on the date specified above, for the election.
