NOTIFICATION

No.322/AP-LC/2/2011: - WHEREAS, the Governor of the State of Andhra Pradesh has, by notification issued under section 16 of the Representation of the People Act, 1951 (43 of 1951) and published in the official Gazette of the State on 25th February, 2011, been pleased to call upon each of the Council Constituencies, specified in column (1) of the Table below, to elect the number of members specified against that Constituency in column (2) of the said Table, to the Legislative Council of the State of Andhra Pradesh.

(A) appoints, with respect to the said election in each of the Constituencies,

- (a) the 4th March, 2011 (Friday), as the last date for making nominations;
- (b) the 5th March, 2011 (Saturday), as the date for the scrutiny of nominations;
- (c) the 7th March, 2011 (Monday), as the last date for the withdrawal of candidatures;
- (d) the 21st March, 2011 (Monday), as the date on which a poll shall, if necessary, be taken; and
- (e) the 27th March, 2011 (Sunday), as the date before which the election shall be completed; and

(B) fixes the hours from 8.00 A.M. to 4.00 P.M., as the hours during which the poll shall, if necessary, be taken on the date specified above for the election.
