

## **FAQs ON ENROLLMENT IN ELECTORAL ROLL**

**Q1. For inclusion of names in electoral roll:**

**Ans.** Persons should be 18 years of age as on 1.1.2010, Fill up Form-6, attach two photos and residence and age proof.

**Q2. For correction of entries in the electoral rolls:**

**Ans.** Use Form-8

**Q3. For any objection on inclusion of names:**

**Ans.** Use Form – 7

**Q4. For change of address**

**Ans.** Use Form -8A

**Q5. Where to get applications-6, 7, 8 & 8A?**

**Ans.** Download from [www.eci.nic.in](http://www.eci.nic.in) or [www.ceoandhra.nic.in](http://www.ceoandhra.nic.in) or post office (GHMC area) or from the Offices of Sub-Collector / Revenue Divisional Officer / Mandal Revenue Officer.

**Q6. Where to submit applications-6, 7, 8 & 8 A?**

**Ans.** Citizens residing in GHMC area can submit applications at nearby Post Office. Citizens residing outside GHMC area can submit applications at the Offices of Sub-Collector / Revenue Divisional Officer / Mandal Revenue Officer.

**Q7. No action on the application submitted earlier? Acknowledgement is there, but name not included.**

**Ans.** Please verify the draft roll published on 28.05.2010. Draft rolls are available on web site [www.ceoandhra.nic.in](http://www.ceoandhra.nic.in) or Sub-Collector / Revenue Divisional Officer / Mandal Revenue Officer. For GHMC area, the rolls are available at the offices of Deputy Municipal Commissioners. If not found, kindly submit Form-6

**Q8. How long will it take my application to be processed?**

**Ans.** Minimum 15 days. But, it can be verified in the rolls to be published on 17.07.2010.

**Q9. There are mistakes in my EPIC. Where can I get them rectified?**

**Ans.** For Citizens residing in GHMC area can rectify at e-Seva centres by submitting Form-8. Outside GHMC area, at ERO Offices.,ie., Sub-Collector / Revenue Divisional Officers (after 17.07.2010)

**Q10. Some of my family members have been left out in the roll. How do I enroll them?**

**Ans.** Apply in Form-6 along with two photographs

**Q11. My name is included in the electoral roll, but EPIC has not been received?**

**Ans.** Citizens of GHMC area can obtain EPIC from e-Seva centres from 17.07.2010. For outside GHMC area, they can obtain from R.D.O offices

**Q 12. Can a non-citizen of India become a voter?**

**Ans.** No Please

A person who is not a citizen of India cannot be registered as a voter. Article 326 of the Constitution read with Sec. 16 of R. P. Act, 1950 clarify the point.

**Q 13. If I am working and living in other districts of A.P. / Other States, can I be a voter in my native village?**

**Ans.** No please

If you are working in other district or outside the State and residing there, you are an ordinary resident of that place in terms of Sec 19 (b). Therefore you can be enrolled at the place where you are residing only and not in your native village.

**Q 14. Can a person working in foreign county be enrolled?**

**Ans.** No please

**Q 15. Can one be enrolled at more than one place?**

**Ans.** No please

A person cannot be enrolled as a voter in more than one place in the same constituency or in more than one constituency in view of the provisions contained under Sec. 17 and 18 of R. P. Act, 1950.

**Q.16. My old EPIC Card is defective. I would like to have a new EPIC Card with correct particulars. What is the procedure?**

**Ans.** You can get your EPIC rectified by depositing it in the Office of the ERO i.e., (RDOs) and in the case of GHMC, e-Seva Centres after 17.07.2010.

**Q.17. I am a tenant and my landlord does not want me to get enrolled. How can I get enrolled as a voter?**

**Ans.** To get enrolled in the voter list is your statutory right. Please check the Electoral roll of your area ERO (SDM)/AERO office. If your name is not included please fill up Form 6 and deposit it with the ERO.

**Q.18. I have lost my old EPIC Card. How can I get a new EPIC Card?**

**Ans.** You can contact e-Seva centre or RDO's Office.

**Q.19. Is the process of enrolment for any specific period?**

**Ans.** No. You can register your name at any time under continuous updation. What is being launched now is only an intensive short duration drive to cover uncovered voters.

**Q.20. Who is responsible for the preparation of Electoral Rolls?**

**Ans.** The Electoral Registration Officer i.e., Revenue Divisional Officer / Sub-Collector / Deputy Municipal Commissioner

**Q.21. Who appoints the Electoral Registration Officer ?**

**Ans.** Election Commission of India in consultation with the State Government.
