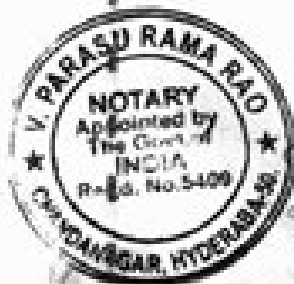



Since a case U/s 406 of IPC was filed against me, on the file of Addl. JFCM West & South, R.R.District in C.C.No.1035 of 2002, the Hon'ble Court was please to fine Rs.5,000/- along with sentence of six months imprisonment, aggrieved by the same an appeal was preferred by me and the same was disposed of by the Court of Honourable Metropolitan Session Judge, L.D.Nagar, Cyberabad in Criminal Appeal No.97 of 2004, dated January 04, 2008, while setting aside the imprisonment and conforming the fine, copy of the same is enclosed herewith. Being aggrieved by the above Appellate order, a Revision was preferred before the Hon'ble High Court of Andhra Pradesh and the same is pending adjudication. Therefore I would submit that the above stated facts will not attract the provisions U/s 8 (1,2 &3) of Representation of the People Act, 1951.
