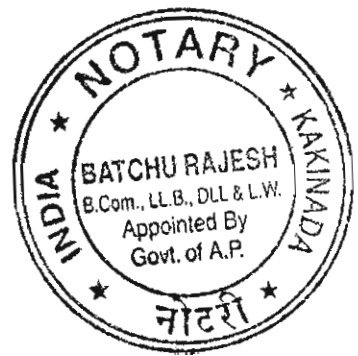


Sir,



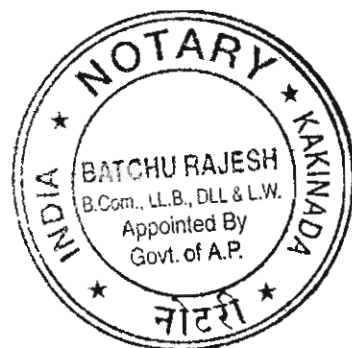

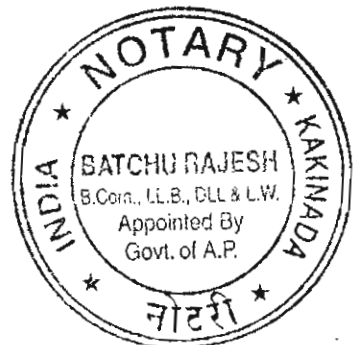
