**ELECTION COMMISSION'S NOTIFICATION UNDER SECTION 149, 30 AND 56 OF  
THE REPRESENTATION OF THE PEOPLE ACT, 1951 – APPOINTMENT OF THE  
DATES AND FIXATION OF HOURS OF POLL FOR THE BYE-ELECTION TO THE  
HOUSE OF THE PEOPLE FROM 38-KADAPA PARLIAMENTARY  
CONSTITUENCY.**

The following notification No. 100/AP-HP/1/2011 of the Election Commission of India, New Delhi, dated the 11th April, 2011 / 21 Chaitra, 1933 (Saka) is re-published:-

**NOTIFICATION**

No. 100/AP-HP/1/2011: - **Whereas**, the seat of Shri Y.S. Jagan Mohan Reddy in the House of the People from the State of Andhra Pradesh, elected from 38-Kadapa Parliamentary Constituency has become vacant on 29.11.2010, by reason of his resignation; and

**2. Whereas**, a bye-election is to be held for the purpose of filling the vacancy so caused;

3. **Now, therefore,** in pursuance of sub-section (1) of Section 149, 30 and 56 of the Representation of the People Act, 1951 (43 of 1951), the Election Commission of India hereby:-

(A) **Calls upon** the said 38-Kadapa Parliamentary Constituency in the State of Andhra Pradesh to elect, before the 15<sup>th</sup> May, 2011 (Sunday) and in accordance with the provisions of the said Act and of the rules and orders made thereunder, a person, for the purpose of filling the said vacancy in the House of the People; and

(B) **Appoints,** with respect to the said election -

- (a) the 18.04.2011 (Monday), as the last date for making nominations;
- (b) the 19.04.2011 (Tuesday), as the date for the scrutiny of nominations;
- (c) the 21.04.2011 (Thursday), as the last date for the withdrawal of candidatures;
- (d) the 08.05.2011 (Sunday) as the date, on which a poll shall, if necessary, be taken;
- (e) the 15.05.2011 (Sunday), as the date before which the election shall be completed, and

(C) **Fixes the hours** from **8.00 A.M.** to **5.00 P.M.**, as the hours during which the poll shall, if necessary, be taken on the date specified above for the election.
