ELECTION COMMISSION'S NOTIFICATION UNDER SECTIONS 150, 30 AND 56 OF THE REPRESENTATION OF THE PEOPLE ACT, 1951 – APPOINTMENT OF THE DATES AND FIXATION OF HOURS OF POLL FOR THE BYE-ELECTION TO THE ANDHRA PRADESH LEGISLATIVE ASSEMBLY FROM 122-TEKKALI ASSEMBLY CONSTITUENCY.

The following notification No. 100/AP/LA/1/2009 of the Election Commission of India, New Delhi, dated the 17th August, 2009 / 26 Sravana 1931 (Saka) is published;-

NOTIFICATION

No. 100/AP-LA/1/2009 :- Whereas, the seat of Dr. K. Revatipathi in the Legislative Assembly of the Andhra Pradesh State, elected from 122-Tekkali Assembly Constituency, has become vacant on 04-06-2009, by reason of his death; and

2. **Whereas**, a bye-election is to be held for the purpose of filling the vacancy so caused;

3. **Now**, therefore, in pursuance of sub-section (1) of Section 150, and Sections 30 and 56 of the Representation of the People Act, 1951 (43 of 1951), the Election Commission of India hereby :-

(A) **Calls upon** the said 122-Tekkali Assembly Constituency in the State of Andhra Pradesh to elect, before the 17th September, 2009 (Thursday) and in accordance with the provisions of the said Act and of the rules and orders made thereunder, a person, for the purpose of filling the said vacancy in the Legislative Assembly of the State; and

(B) Appoints, with respect to the said election,-

- (a) the 24-08-2009 (Monday), as the last date for making nominations;
- (b) the 25-08-2009 (Tuesday), as the date for the scrutiny of nominations;
- (c) the 27-08-2009 (Thursday), as the last date for the withdrawal of candidatures;
- (d) the 10-09-2009 (Thursday), as the date, on which a poll shall, if necessary be taken;
- (e) the 17-09-2009 (Thursday), as the date before which the election shall be completed, and

(C) Fixes the hours from **7.00 A.M.** to **5.00 P.M.**, as the hours during which the poll shall, if necessary, be taken on the date specified above for the election.
