NOTIFICATION

- (a) the 22nd February, 2011 (Tuesday), as the last date for making nominations;
- (b) the 23rd February, 2011 (Wednesday), as the date for the scrutiny of nominations;
- (c) the 25th February, 2011 (Friday), as the last date for the withdrawal of candidatures;
- (d) the 13th March, 2011 (Sunday), as the date on which a poll shall, if necessary, be taken; and
- (e) the 21st March, 2011 (Monday), as the date before which the election shall be completed; and

(B) fixes the hours from 8.00 A.M. to 4.00 P.M., as the hours during which the poll shall, if necessary, be taken on the date specified above for the election.
