**ORDER:**

The Election Commission of India in the references read above, have announced the scheduled for conduct of elections to A.P. Legislative Council. They have also informed that the Government of India, Ministry of Personnel in their Office Memorandum No.12/7/ 94-JCA; dt. 16-05-1994 have allowed Special Casual Leave to all Central Government employees who are University Graduates and are bonafide voters in the elections to the State Legislative Councils from Graduates' and Teachers' Constituencies and requested State Government to issue orders on similar lines. As per the schedule for A.P. Legislative Council Elections, the polling for Graduates and Teachers Constituencies will be taken up on 17-03-2007. Certain Associations, contesting candidates / election agents have also requested to declare the poll day as a general holiday.

2. Government have examined the matter carefully. Keeping in view of the suggestion of the Election Commission of India Government hereby direct that the appropriate authorities under the State Government shall grant Special Casual Leave to such of their employees who are registered voters in Teachers / Graduates constituencies to enable them to exercise their right of franchise in the elections to State Legislative Council to be held on 17-03-2007.

3. The Departments of Secretariat / Heads of Departments / District Collectors and other Subordinate Officers are requested to take necessary action accordingly.

4. This order issues with the concurrence of Finance and Planning (FW.FR) Department vide their U.O. No. 6974/153/FR.I/07; Dated 14-03-2007.
